Under the direct supervision of the Governor, the Nebraska Department of Banking and Finance (NDBF) has a mission to protect and maintain the public's confidence through fair, efficient, and experienced supervision of the state-regulated financial services industries.

Created by the Nebraska Legislature in 1933 to regulate state-chartered banks and other financial industries, the department was authorized to also regulate securities in 1939. Today, the agency is funded entirely by the industries it regulates.

The NDBF serves the citizens of Nebraska through various duties. Field staff examines state-chartered financial institutions, delayed deposit service businesses, and other industries to ensure sound operations and compliance with state laws. The department also registers securities offered in Nebraska, business opportunities, investment advisors and broker-dealers. Staff investigates securities violations and consumer complaints against state-chartered or -licensed entities.

Noteworthy developments in Fiscal Year 2024-25 include the following:

- The Nebraska Legislature passed and Governor Jim Pillen signed LB 474, which authorizes NDBF-recommended changes to modernize the oversight of consumer finance lenders and money transmitters.
 These important updates take effect October 1, 2025.
- The NDBF received its reaccreditation designation from the Conference of State Bank Supervisors, bringing national recognition relative to standards for bank examinations and examiner training.
- The Legislature passed and Governor Pillen signed LB 609, which grants the NDBF new oversight responsibility in regulating cryptocurrency kiosks or ATMs.
- The NDBF launched its new "Make Cents Make Sense" initiative and website with a long-term goal of arming Nebraskans with the information they need to grow their savings and fight fraud.

The NDBF's vision is to make Nebraska the most trusted financial home for people and businesses. With this vision as a guiding light, the department is growing new opportunity for our next generation.

NDBF's Vision: To Make Nebraska the Most Trusted Financial Home for People and Businesses.

DEPARTMENT OVERVIEW

The Nebraska Department of Banking was created by state legislators in 1933 to regulate state-chartered banks and other financial industries within the state. In 1939, regulation of state securities laws was also placed under the jurisdiction of the Department.

Today, the Nebraska Department of Banking and Finance (NDBF) regulates and supervises various financial industries on behalf of the State of Nebraska and its residents. This state agency is under the direct supervision of the Governor, and the Director of Banking and Finance is appointed by the Governor. The NDBF draws no funds from Nebraska's General Fund. The agency is funded entirely by regulated industries.

The NDBF is comprised of two sections: Financial Institutions and Bureau of Securities. Together, these two sections regulate several different financial industries.

Our Vision

To make Nebraska the most trusted financial home for people and businesses.

Our Mission

- Protect and maintain public confidence through the fair, efficient, and experienced supervision of the state-regulated financial services industries.
- Assist the public in their dealings with those entities.
- Assist those we regulate in a manner that allows them to be competitive, while ensuring their soundness in compliance with the law.
- Fulfill statutory responsibilities regarding all licensees and registrants.
- Investigate violations of the law and cooperate with other agencies in seeking a timely resolution of problems and questions.

What We Do

- Examine state-chartered banks, credit unions, and other state-licensed industries to ensure sound operations and compliance with state law.
- Register securities, investment advisors, broker-dealers and franchise filings.
- Investigate securities violations and consumer complaints.
- Educate industry and the public about financial services and how to protect themselves.

FROM THE DIRECTOR

This is an exciting time at the Nebraska Department of Banking and Finance.

Department staff are reminded daily that it's an honor to serve Nebraskans and the state's banking and finance stakeholders. As public servants, we are also reminded that it's a privilege to be part of history in the making – all while protecting and maintaining the public's confidence through fair, efficient, and experienced supervision of the financial services industries.

Indeed, the last year has brought much change to the world of banking and finance – perhaps as much as any time since the Nebraska Legislature created the agency nearly a century ago. The NDBF team has responded remarkably well.

Here is a look at some key NDBF achievements during Fiscal Year 2024-25:

CSBS Reaccreditation

The Department received its reaccreditation designation from the Conference of State Bank Supervisors (CSBS). The CSBS Accreditation Program involves an in-depth review of agency policies, procedures, and operations to determine if they meet the standards set by the CSBS Performance Standards Committee. I'm extremely proud of our staff for the months of work that went into the NDBF's reaccreditation, which brings national recognition for our bank examinations and examiner training.

Modernizing NDBF Oversight

The Nebraska Legislature passed and Governor Jim Pillen signed LB 474, which authorizes

NDBF-recommended changes to modernize the oversight of consumer finance lenders and money transmitters. Among other provisions, the law eliminated the Nebraska Installment Loan Act – after merging certain provisions with the Nebraska Installment Sales Act, while also creating a new Nebraska Installment Loan and Sales Act. LB 474 also updated and modernized the Nebraska Money Transmitters Act. These important updates will help the NDBF better serve both consumers and industry stakeholders.

Crypto ATM Regulation

The Legislature also passed and Governor Pillen signed LB 609, granting the NDBF new oversight responsibility for cryptocurrency kiosks or ATMs. While these machines offer a legitimate and convenient way to buy cryptocurrency, they are also a favored tool of scammers. The bill's provisions include a requirement that crypto ATM operators obtain a license issued by the Department, register the location of each machine, and issue refunds to consumers under certain conditions. The NDBF spent the latter half of the fiscal year preparing for successful implementation of the law, which takes effect September 2, 2025.

'Make Cents Make Sense'

The NDBF launched its "Make Cents Make Sense" initiative to help provide Nebraskans with information to grow their savings, invest wisely, and avoid financial fraud. NDBF staff shared their expertise during interviews with 10/11 News, while our website, MakeCentsMakeSense.Nebraska.gov – spotlighted through NDBF social media – offers trusted, no-cost resources on key topics, such as how to build an emergency fund, open a savings account, use compound growth to grow investments, and recognize common scams. The site accumulated nearly 9,000 page views in its first four months online.

Nebraskans have always embraced innovation and adapted to change to ensure a brighter future. The rapid pace of change in the banking and finance sector is simply the latest chapter in the Cornhusker State's pioneering spirit. Our Department is proud to play an important role in helping grow new opportunities for the next generation.

SPOTLIGHT: 'MAKE CENTS MAKE SENSE'

New Initiative to Grow Financial Awareness, Fight Fraud

The NDBF launched "Make Cents Make Sense" in April 2025, which was proclaimed as Financial Awareness Month by Governor Jim Pillen. The aim of "Make Cents" is to help Nebraskans save more money, invest wisely, and fight fraud.

The initiative includes a new website at MakeCentsMakeSense.Nebraska.gov. The site provides trusted, no-cost, and unbiased resources on important financial topics, including:

- · Tips to prevent financial fraud;
- · Actions to take if you're a victim of a scam;
- · How to protect older Nebraskans from fraud;
- Steps to build an emergency fund or open a savings account;
- How to use compound growth to grow your wealth; and
- Saving and investing terms to know.

The site also features links to a budgeting worksheet, savings calculator, mutual fund analyzer, infographics, printable publications, and fraud-prevention resources from other government agencies.

New content is added regularly, and visitors can use the website to report scams to NDBF staff.



In its first three months of operation, the site attracted more than 4,000 visits and nearly 7,300 individual pageviews.

NDBF staff conducted public outreach and disseminated financial awareness materials through the Department's social media platforms, as well as guest editorials published by community newspapers and broadcast outlets.

NDBF staff also took part in interviews hosted and aired by 10/11 News in Lincoln. Topics included "pig butchering" relationship scams, the dangers of "money mules," and the importance of establishing an emergency savings account.

NDBF Director Kelly Lammers said: "Financial awareness empowers individuals and families. It is through awareness that 'Make Cents Make Sense' will help ensure a brighter financial future for Nebraskans."

NDBF Deputy Director for the Bureau of Securities Claire McHenry stated: "Make Cents Make Sense' is more than just a website – it represents the Department's ongoing mission to help Nebraskans secure their finances."

FINANCIAL INSTITUTIONS

Fiscal Year 2024-25 brought new milestones to the NDBF's Financial Institutions (FI) Division.

The FI staff administers and enforces laws and regulations for both depository and consumer finance industries in Nebraska. Here is a closer look at what our team does daily:

The FI depository division supervises banks, credit unions, and trust companies.

The FI consumer financial services division supervises mortgage bankers, money transmitters, installment loan and sales finance companies. We also license the individuals conducting business in each of these industries, while overseeing digital asset depository charters.

The FI examination team consists of 37 examiners who provide Nebraska financial industries and our state and federal regulatory counterparts with expertise in various areas. The FI division conducted a total of 128 examinations of Nebraska chartered or licensed financial institutions this year.

Here is a look at some of the FI Division's achievements during Fiscal Year 2024-25:

NDBF Honored by CSBS for Reaccreditation

The Conference of State Bank Supervisors (CSBS) – a 123-year-old national association that oversees the state financial regulator accreditation process – recognized the NDBF's reaccreditation for the department's banking and mortgage supervision responsibilities. Governor Jim Pillen presented the CSBS plaques to NDBF Director Kelly Lammers and other agency staff. Reaccreditation was earned after NDBF staff participated in a multi-month peer review.

Accreditation is vital to fulfilling our agency's statutory obligation and ensuring the NDBF carries out its most fundamental duties of examinations, licensing, and enforcement.

Nebraska Remains a State-Charted Banking Leader

In fiscal year 2024-25, the NDBF oversaw 134 state-chartered banks, or more than 90% of banks doing business in Nebraska. The Cornhusker State is ranked No. 8 in the nation in the number of state-chartered banks. These Nebraska banks oversee more than \$69 billion in total assets.

Additionally, a total of 10 credit unions hold a Nebraska charter with total assets of \$1 billion. Nebraska now charters five independent trust companies with combined assets under management of \$14.4 billion. Meanwhile, the agency also oversees 529 licensed mortgage bankers and another 4,436 licensed mortgage loan originators, 200 Money Transmitters licenses, 137 Installment Loan Companies, and 110 Sales Finance Companies.

Overall, financial industries are innovative and growing in Nebraska to remain a safe and trusted home for people and businesses.

Forging Ahead With Digital Assets


NDBF continues its work to implement the Nebraska Financial Innovation Act (NFIA), which provides expanded opportunities for the financial sector in our state, while giving consumers and businesses better control of their money.

Specifically, the NFIA authorizes the establishment of a state-chartered digital asset bank, which, among other things, can create or "mint" a stablecoin. In early 2025, the NDBF issued its first-ever order approving a digital asset depository institution.

Once the conditions in that order are met, the institution will be able to issue its own stablecoin for consumer use.

Under Nebraska law, for every stablecoin issued by a state-authorized digital asset depository, a corresponding U.S. dollar must be held in an FDIC-insured bank account or U.S. Treasury investment.

OVERVIEW: FINANCIAL INDUSTRIES



This chart shows the growth of total assets held by Nebraska state-chartered banks from the end of 2013 through Q2 of 2025. Assets nearly doubled over this period, rising from approximately \$35 billion in early 2014 to nearly \$70 billion by mid-2025.

BUREAU OF SECURITIES

The Bureau of Securities continued its efforts to protect investors and Grow Nebraska in FY 2025. The Bureau administers and enforces the Securities Act of Nebraska ("Act"), as well as several other consumer and business protection statutes to protect investors and promote fair and efficient markets in Nebraska. Strong state securities regulation is essential to maintain a stable securities industry, protect the public from illegal operations, and encourage capital formation and the creation of new jobs in Nebraska.

The Act provides for the registration or exemption of securities, registration of firms and individuals, examination of registered firms, and enforcement of the Act through administrative, civil, and criminal actions. This is possible due to the hard work and dedication of the Bureau's specialists, analysts, examiners, supervisors, and legal staff.

The Bureau remains a net contributor to the General Fund of the State of Nebraska. In FY 2025, the Bureau's expenditures were \$1,663,794, and the revenue collected was \$29,871,532, primarily from registration and licensing fees. The bureau transferred \$39,500,000 from the Securities Act Cash Fund to the General Fund. Since 2020, the Bureau has transferred \$175,009,578 to the General Fund. Since 2000, the Bureau has transferred over \$613,009,578 to the General Fund.

The Bureau conducted outreach and presented on topics important to investors and the financial industry in Nebraska and the United States. The Bureau hosted its annual compliance webinar for state registered investment advisers on annual renewal requirements and new rules impacting investment advisers. On March 6, 2025, Deputy Director Claire McHenry provided testimony before the SEC Investor Advisory Committee on state securities perspectives on retail investor fraud in America. During Financial Awareness Month in April 2025, the Department launched a multi-media outreach campaign, Make Cents Make Sense, to bring relevant and targeted information to Nebraska investors and consumers about how investment works and how to protect themselves from fraud. 
Effective September 18, 2024, the Department adopted model rules from the North American Securities Administrators Association ("NASAA") that:

- Allow broker-dealer agents to participate in FINRA's Maintaining Qualifications Program,
- Amend provisions relating to investment adviser policies and procedures,
- Allow investment adviser representatives to participate in the Exam Validity Extension Program,
- Require investment adviser representatives to complete continue education, and
- Provide that a failure to pay arbitration awards, court judgments, and regulator fines is an unethical business practice.


Registration ensures that investors receive important information about securities products and the investment professional with which they work, so that they can make informed decisions about their financial futures. Examinations of registered investment advisers and broker-dealers allow the Bureau to review the firm's compliance programs, detect violations of the Act, and help strengthen internal practices. Common exam finding addressed corrections to disclosure documents, amendments to advisory contracts, insufficient policies and procedures, failure to make and keep required books and records, excessive fees, and insufficient suitability information.

The Bureau engaged in active enforcement of the Act in FY 2025. The Department continues to support the efforts of the receiver appointed in the matter involving First SOJO Capital Group, LLC and Jesse Hill for violations of the Securities Act. In June 2025, Hill entered a guilty plea in U.S. District Court for conspiracy to commit bank fraud and is currently awaiting sentencing. The Department joined a multi-state settlement and entered a consent order with Edward D. Jones & Co. to address failures supervise the transfer of certain brokerage account assets into advisory accounts that resulted in clients being charged front-load commissions where the customer sold or moved funds sooner than anticipated. The Department joined a multistate settlement with GSB Gold Standard Corporation AG, GSB Gold Standard Pay Ltd., and affiliated GS Partners companies and its owner, Josep Heit for unregistered sales of securities involving cryptocurrencies. The Department joined a multi-state settlement and entered a consent order with Vanguard Marketing Corporation and The Vanguard Group Inc. to address failures to supervise certain registered persons and the non-disclosure of potential tax consequences to investors following changes in investment minimums for specific target date retirement funds.







Legislation and regulation updates for the fiscal year ending June 30, 2025 are detailed in this section.

This was a busy year, and I am very proud of the members of the Legal Division for their excellent and comprehensive work and their dedication to serving Nebraskans. Thank you all.

Legislation

Three legislative proposals were brought on behalf of the Department in the First Session of the 109th Legislature: LB 251, LB 473, and LB 474. It was an ambitious agenda.

LB 251 was introduced by Banking, Commerce and Insurance Committee (BCI) Chairperson Mike Jacobson. This was our omnibus bill to update and clarify laws the NDBF administers. It contained the annual depository financial institutions' equal rights updates, along with a new reference date of January 1, 2025 for 21 cross-referenced federal statutes, regulations, and standards. We work to keep these current to avoid duplication and over-regulation.

LB 251 also included amendments to:

- The bank lending limit statute for loans secured by livestock or warehouse receipts to align state law with the national bank lending limit;
- Section 8-1506 to permit the Director to authorize a Nebraska state-chartered financial institution to acquire an out-of-state financial institution on an emergency basis;
- Authorize applicants for financial institution charters to use the term allowed to that charter;

- The bank and credit union branching laws to shift the responsibility for publications of notices of applications from the Department to the applicant;
- The Residential Mortgage Licensing Act related to mortgage banker surety bonds; and
- The Loan Broker Act to exempt credit unions and subsidiaries of banks.

LB 251 was signed into law by Governor Pillen with an emergency clause. It became law March 12, 2025.

LB 473, introduced as a BCI Committee bill, proposed to update the Nebraska Money Transmitters Act to conform with the model Money Transmission Modernization Act ("Model Act"). The Model Act was the result of a multi-year collaborative process with the Conference of State Bank Supervisors, other state regulators, and industry stakeholders.

LB 473 incorporated much of the Model Act language while retaining provisions that had proven effective in Nebraska for efficient regulation of the payments industry, such as exemptions for other regulated industries (e.g., debt collectors), and the authority of the Department to issue notices of cancellation or abandonment rather than going through formal processes for revocations or denials. Application and renewal fees were increased and a change of control fee added.

LB 474 was introduced to update and modernize the Installment Loan Act ("ILA") and supervisory processes. LB 474 took select provisions of the current ILA, combined those with the current Installment Sales Act ("ISA"), repealed the existing ILA, and renamed the combined legislation as the Installment Loan and Sales Act ("ILSA"). Separate licenses for the different entities will continue under the ILSA, but the licensing processes will essentially be identical, with no hearing requirement for any applicant.

Another significant change allows branch licensing for installment loan companies so that licensees with more than one location will no longer be required to have separate full company licenses for each office, thus avoiding duplication of policies, books, and examinations. LB 474 made no changes to the

interest rates, fees, or other charges that these companies can impose on consumers.

LB 474 was also a BCI Committee bill and was designated a Committee priority bill. LB 473, which had been advanced to General File, was amended in its entirety into LB 474. The bill was passed unanimously by the Legislature and signed by Governor Pillen on May 20, 2025.

All sections of the bill relating to the Money Transmitters Act and the Installment Loan and Sales Act become effective October 1, 2025.

The Department is grateful to Senator Jacobson for his introduction of LB 251 and to the BCI Committee for introducing LB 473 and LB 474.

We appreciate the work of Senator Jacobson and BCI Committee Counsel Joshua Christolear in successfully shepherding the agency legislation.

Other Legislation

Director Kelly Lammers testified on these additional bills:

- LB 250, introduced by Senator Jacobson, to revise the residency requirements of bank board of directors. The Department appeared in a neutral capacity, suggesting clarification of a key term.
- LB 591, introduced by Senator Beau Ballard, to amend the Installment Loan Act. Director Lammers presented concerns with the bill and pledged to continue discussions to resolve issues.
- LB 609, introduced by Senator Eliot Bostar, to adopt the Controllable Electronic Record Fraud Prevention Act, which included a requirement that operators of cryptocurrency kiosks/ATMs be licensed under the Nebraska Money Transmitters Act. The Department was in support of the bill with a proposed amendment. LB 609 passed and became effective September 2, 2025.

Other bills of significance to financial institutions that were adopted by the Legislature include:

- **LB 231,** adopting the Uniform Special Deposits Act promulgated by the Uniform Law Commission.
- LB 232, requiring notices to assignees of a pending lapse or termination of a life insurance policy.
- LB 241, providing that a private entity will not be liable in a class action resulting from a cybersecurity event unless caused by the entity's negligence.
- LB 341, adopting a uniform act for minor children receiving insurance settlement funds of \$35,000 or less.
- LB 422, updating the disclaimers within the Nebraska Uniform Real Property Transfer on Death Act to include a new warning regarding a homeowner's insurance policy and requiring certain coverage of the named beneficiary.
- LB 559, creating a new criminal offense for the installation and use of a skimmer device and enacting a "kingpin" law for organized financial crimes.

Regulations

Revisions to Title 48, Chapters 6, 7, 9, and 12 became effective September 18, 2024.

These are rules under the Securities Act of Nebraska and impact broker-dealers, investment advisers, investment adviser representatives, and business practices.

The Financial Institutions Fund primarily generates revenue from an annual assessment based on assets, as well as examination fees. The Bureau of Securities is funded through fees associated with the registration of securities and the licensing of securities industry professionals.

DEPOSIT LIMITATIONS

Nebraska has adopted a deposit cap as set forth in the Nebraska Bank Holding Company Act. Section 8-910 provides that a holding company may not acquire a bank or banks in Nebraska if the deposits held in Nebraska would be in an amount greater than 22 percent of the total deposits of all banks in Nebraska plus the total deposits, savings accounts, passbook accounts, and shares in savings and loan associations and building and loan associations in Nebraska as determined by the Director of the Department on the basis of the most recent mid-year reports.

Total deposits for all banks and savings and loan associations in Nebraska as of June 30, 2025, were **\$92,460,575,000**. The number was taken from a Federal Deposit Insurance Corporation compilation.

The 22% limitation contained in Section 8-910(2)(c), as of June 30, 2025, would be:

\$20,341,326,500



To spotlight World Elder Abuse Awareness Day and scams that target Nebraska's seniors, Director Kelly Lammers in June 2025 appeared on an episode of "Live and Learn," a monthly TV show produced by Aging Partners, which serves eight counties in southeast Nebraska.

SINGLE BANK POOLED COLLATERAL PROGRAM

The Single Bank Pooled Collateral Program (SBPC) was authorized by legislative bill (LB) 622 in 2020. The bill was signed into law and became effective as of July 1, 2020. The bill revised portions of the Public Funds Deposit Security Act (Neb. Rev. Stat. §§77-2386 – 77-23, 108) to provide financial institutions an alternate means by which to secure public funds held on deposit. In contrast to the dedicated method of pledging securities directly to individual public entities, the SBPC allows financial institutions to pledge a pool of securities to all public deposits held in excess of the FDIC insurance limits.

LB622 authorized the Department to appoint an administrator for the SBPC. In May of 2020, the Department appointed Nebraska Bankers Insurance and Services Company (NBISCO) as the program administrator. NBISCO's appointment runs through June 30, 2026. The appointment may be renewed for an additional two-year term.

The SBPC began accepting participating financial institutions as of July 1, 2020. Since that date, the program has grown to include 30 participating financial institutions as of June 30, 2025. Total public deposits in the program total over \$2.5 billion.

Under the leadership of Governor Jim Pillen, the NDBF has been working to implement the groundbreaking Nebraska Financial Innovation Act (NFIA), which aims to give consumers and businesses better control of their money in the modern era. Specifically, the act authorizes the creation and regulation of digital asset depositories, which enable the use of digital assets for payment purposes. The NFIA authorizes the establishment of a state-chartered digital asset bank, which, among other things, can create or "mint" a stablecoin. This paves the way for a new type of financial transaction in our traditional banking system – one in which all parties immediately know that the funds are sufficient and readily available. Previously, this was only possible when dealing in cash. Under Nebraska law, for every stablecoin issued by a state-authorized digital asset depository, a corresponding U.S. dollar must be held in an FDIC-insured bank account or U.S. Treasury investment.
