COMES NOW the Nebraska Department of Banking and Finance ("Department"), by and through its Director ("Director"), pursuant to Neb. Rev. Stat. § 8-1108.01(5) (Cum. Supp. 2016), and finds:

1. On February 22, 2017, the DEPARTMENT issued Findings of Fact, Conclusions of Law and Order to Cease and Desist ("Order") to Blazefly, Inc. ("Blazefly"); Jamie L. Crager ("Crager"), President, and their affiliates, control persons, officers, directors, agents, employees and employees, ordering them to immediately cease and desist from the further offer and sale of securities without compliance with the Securities Act of Nebraska, Neb. Rev. Stat. §§ 8-1101 to 8-1124 (Reissue 2012; Cum. Supp. 2016).

2. Blazefly timely filed a written request for hearing on the Order. By order dated March 23, 2017, a hearing was scheduled for May 1, 2017, at 9:30 a.m. at the office of the Department.

3. On April 20, 2017, Blazefly withdrew its request for a hearing on the Order thereby consenting to the Order becoming final.

IT IS THEREFORE ORDERED that:

1. The Findings of Fact, Conclusions of Law and Order to Cease and Desist issued by the Department On February 22, 2017, is hereby final as to all parties.


2. The hearing scheduled for May 1, 2017, at 9:30 a.m. is hereby cancelled.
